On the Application of The International Association of Bridge, Structural, Ornamental and Reinforcing Ironworkers, Local Union 728, a creditor, of Aabacus Welding Inc., in The City of Winnipeg, in the Province of Manitoba, filed on the 4th day of November, 2019;

Partridge, sworn December 2, 2019, the Affidavit of Kyla Simms, sworn December 3, 2019, the Supplementary Affidavit of Rob Duarte, sworn December 3, 2019, and having heard the oral evidence of Jasper Sevillano and the submissions for counsel for the Applicant and counsel for the Respondent, no one appearing for any other person.

AND it appearing to the Court that the following act of bankruptcy has been committed:

Aabacus Welding Inc. has ceased to meet its liabilities generally as they become due within the six months preceding the date of the filing of the Application for Bankruptcy Order;

1. THIS COURT HEREBY ORDERS that Aabacus Welding Inc. of 535 Bluecher Avenue, of The City of Winnipeg, in the Province of Manitoba, be adjudged bankrupt by virtue of a Bankruptcy Order hereby made on December 6, 2019.
2. THIS COURT FURTHER ORDERS that Lazer Grant Inc. of The City of Winnipeg, of the Province of Manitoba, be appointed as trustee of the estate of the bankrupt.
3. THIS COURT FURTHER ORDERS that the trustee give security, in an amount and form to be fixed by the Official Receiver pursuant to section 16(1) of the *Bankruptcy and Insolvency Act*, R.S.C. c. B-3, as amended.

4. THIS COURT FURTHER ORDERS that the costs of the applicant creditor be paid out of the estate of the bankrupt on taxation of the estate.


